The 40-hour class will consist of classroom / field instruction covering advanced scenario training principles and adult learning principles. Two (2) days will be dedicated to practical exercises allowing students to implement principles learned during the classroom portion.

Upon completion, students will have an advanced level of knowledge and experience in the field of Reality Based Training program design and implementation.

COURSE OF INSTRUCTION

- Advanced scenario principles
- Adult learning principles
- Officer psychological factors
- How to safety / effectively utilize simulation products from SIMUNITION, ATK, Airsoft, etc.
- The use of protective equipment and confrontational gear
- The use of inert chemical agents, training batons, training radios
- The use of laser simulators such as AIS, IES, FATS, etc.

REQUIRED EQUIPMENT

- Duty belt, duty weapon, duty TASER, and duty baton
- Coveralls or long sleeve BDU's
- Eye protection suitable for range training
- 50 rounds of SIMUNITION FX marking cartridges
- Writing instruments
- Open mind

- Guns modified for use with SIMUNITION FX marking cartridges
- Inert chemical agent, training batons, props
- Protective gear for use with projectile based training
